#### **LEGISLATIVE UPDATE**

We are keeping a close eye on a bill that would put additional limits on police use of force, use of restraint chairs for people in police custody, and police dispersal techniques during protests or demonstrations. Thank you, Senator Dallas Harris, for championing <u>SB 212!</u>

The Outcome: passed the Senate Judiciary on April 2, 2021, by a vote of 12-9. The bill advanced to the Assembly Judiciary on April 23, 2021. Waiting on bated breath for the outcome.
